81/22 Planning Applications

82/22 Report of the Clerk

i) Playground Inspections

Cllr Rogers has inspected both the Recreation Grounds,

Stainsby Meadow

The new bark laid recently has settled and has retained a good depth. The weeds around the fencing have been weed killed and now need to be removed.

A waste dog bin has been removed from Stainsby Meadow, Clerk to ask Amber Valley if they could provide one.

Dobholes Lane

The basket swing has been removed and will be repaired in the next few days.

The Groundsman will tighten the grips on the climbing frame.

The caps which go on the goal posts sleeve are missing, Cllr Rogers to investigate.

The football pitch committee have agreed to let an adult football team play on the ground; however, this is conditional on the committee inspecting the ground prior to match to ensure it is fit to play on.

Cllr Rogers reported that the changing rooms had been left in a poor state after the matches at the weekend and had not been cleaned properly. Also, a bag of rubbish had been thrown onto the top of the changing rooms and litter had fallen into the gutter. Cllr Rogers to contact the Groundsman. Cllr Rogers to see if the watering machine can go into the storage container on Dobholes Lane Recreation Ground.

Cllr Rogers to ask the Groundsman to erect the wrought iron sign at Dobholes Lane Recreation Ground.

Clerk to obtain two more quotations for sand on the recreation ground and look for any grants available.

ii) Stainsby Meadow Entrance Sign

This will be erected in the next few weeks, behind the estate fencing at Stainsby Meadow entrance.

iii) Welcome to Village Signs

Clerk still waiting for the quotation of the installation of the signs and bench seat. Clerk to provide further information next meeting.

iv) Location of SID sign

Derbyshire County Council have agreed to replace the speed sign indicator at the entrance to the village by Smalley Hall at some point, a grant from Derbyshire County Police has been given to the Parish Council for a Speed Indicator Device, members agreed that this should go on Dobholes Lane at the entrance to the village. Clerk to send details to Derbyshire County Council for approval.

v) Approval of Memorial

Members approved the memorial for P F J Greatorex.

vi) Cemetery Guidelines amendment

The Chairman and Clerk to consider the amendment to define the wording of connections with the village when considering what costs are to be applied.

vii) Christmas lights
